Worldwide exposure

Some of the most dynamic opportunities are found outside U.S. borders. To give investors access to such growth potential, the fund may invest up to 50% of its assets outside the U.S. As of 11/30/23, 19% of the fund's holdings were in companies based outside the United States.


Reliance on research

A dedicated team of analysts helps the fund's investment professionals make informed investment decisions by focusing on a specific industry or type of company. To help form well-rounded views of companies, they often meet with employees, customers, suppliers and competitors.

The pace of innovation accelerates

Over the centuries, advancements like railroads, x-rays and personal computers have changed the world – creating potential opportunities for investors. As this chart shows, in general, the pace at which these inventions are adopted globally has been accelerating. For example, while it took much of the world 99 years to adopt the telephone, it took only 16 years to adopt cell phones.


